The Bremer County Board of Supervisors met in session on Monday, August 19, 2019 in the Courthouse, Waverly, Iowa, at 10:00 a.m. Neil, Kammeyer, Hildebrandt present. Finance Director, Kassandra Johansen also present. Unless otherwise noted, all actions were approved unanimously.

Meeting was called to order by Chairman Neil, Hildebrandt moved/Kammeyer second to approve the agenda.

Board met with David Lehman, Roadside Vegetation Mgr. for a department update.

Minutes of the 8/12/19 & 8/14/19 meetings were read and approved.

Kammeyer moved/Hildebrandt second to approve a payroll addition for Allyson Ellwanger, CBS Direct Care Staff, part time, \$12.75/hr., \$8.50/hr. sleep time, effective 8/19/19.

Hildebrandt moved/Kammeyer second to authorize board chair to sign: PROCLAMATION September as Hunger Action Month. WHEREAS, hunger and poverty are issues of grave concern in the United States and in Bremer County; and WHEREAS, the county of Bremer is committed to taking steps to raise awareness about the need to combat hunger in every part of our state and to provide additional resources that citizens of Bremer County need; and WHEREAS, the county of Bremer is committed to working with the Northeast Iowa Food Bank in educating people about the role and importance of food banks in addressing hunger and raising awareness of the need to devote more resources and attention to hunger issues; and WHEREAS, nearly 2,300 individuals in Bremer County rely on food provided by the Northeast Iowa Food Bank and member agencies annually; and WHEREAS, the Northeast Iowa Food Bank distributed more than 6.7 million meals to member agencies, programs and food banks in our region in our last fiscal year; and WHEREAS, food banks across the country, including the Northeast Iowa Food Bank will host numerous events throughout the month of September to bring awareness and attention to encourage involvement in efforts to end hunger in their local community; NOW, THEREFORE, I, Board of Supervisors Chairman Tim Neil, do hereby recognize September, as HUNGER ACTION MONTH in Bremer County and I call this observance to the attention of our citizens.

Board met with Neal Jarnagin, Veterans Affairs Director, for a department update.

Board met with Landon Moore, Engineer, for a weekly update.
