The Bremer County Board of Supervisors met in session in the board room in the Courthouse, Waverly, Iowa, Monday, November 2, 2020 at 9:00 a.m. Neil, Kammeyer & Hildebrandt present. Unless otherwise noted all actions were approved unanimously. Meeting was called to order by Chairman Neil. Hildebrandt moved/Kammeyer second to approve the agenda.

Randy McKenzie, B & Z Admin., presented a proposed amendment to the Flood Plain Ordinance #20-08 for review and consideration.

Board discussed filling the vacancy caused by the death of Edward Fuoss on the Bremer County Board of Adjustment.

Minutes of the previous meeting were read and approved.

Hildebrandt moved/Kammeyer second to approve claims as listed below and authorize Auditor to issue checks.

Hildebrandt moved/Kammeyer second to authorize Board Chair to sign a Strategic Project Agreement between MH/DS of the East Central Region and Community Based Services for an Award of Grant funds from the Bremer County Mental Health fund balance.

Board met with Landon Moore, Engineer, for a weekly Secondary Roads department update. Hildebrandt moved/ Kammeyer second to adopt RESOLUTION NO. 20-83 - ESTABLISHING NO PARKING ZONE. WHEREAS The Board of Supervisors is empowered under authority of Sections 321.239 of the Code of Iowa to restrict the parking of vehicles within the right-of-way of any highway under its jurisdiction, NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF Bremer County that they do hereby authorize the erection of “No Parking” signs and restrict parking on both sides of 250th Street between a point 120 feet east and 600 feet north of US 218 and a point 120 feet east and 1200 feet north of US 218. Passed and adopted this 2nd day of November, 2020.

Board/Committee updates: Neil reported on 2nd Judicial Executive Board, Community Action, and ISAC Executive Board meetings, Neil also met with City of Waverly and Waverly-Shell Rock school to discuss Red Fox Inn property TIF project; Hildebrandt spoke to Kelly Matt regarding Bremer County Board of Adjustment vacancy; Kammeyer participated in IA Workforce Development Board meeting.
