Explanation of increases in the budget:

The increase in the general services budget is due to increases in expenses for liability insurance, wages, and benefits and decreases in revenues for services provided. The increase in the rural services budget is due to the need to continue to provide adequate funding to our secondary roads department to ensure roads and bridges are maintained.

The above tax rates do not include county voted levies, mental health and disabilities services levy, debt service levy and the rates of other local jurisdictions.

Regarding proposed maximum dollars, the Board of Supervisors cannot adopt a higher tax asking for these levies following the public hearing.

Budget year effective property tax rate is the rate that would be assessed for these levies if the dollars requested is not changed in the coming year.
